## SHORELINE PARK SOUTH



## The following are not permitted:

- Watercraft rentals of any kind including pontoons, jet skis, paddle boards, and kayaks, except by Special Event Permit and/or contract with the City of Gulf Breeze
- Vendors of any kind including food trucks and mobile sales, except by Special Event Permit and/or contract with the City of Gulf Breeze
- Large fishing and boating charters; small fishing charters must hold a valid FL US Coast Guard Operator of Uninspected Passenger Vessels (USCG OUPV) license and be registered with a BTR by the Community Services Department
- Smoking, vaping, and tobacco products
- Grills
- Dumping of fish or bait waste
- Fishing from boat launch docks or Dog Beach
- Feeding wildlife, abandoned, and/or feral animals
- Boat trailers separated from vehicles
- Unleashed dogs or pets, except in the Bark Park and Dog Beach
- Leashed dogs and pets under the direct control of the owner are not permitted except on designated nature trails, Bark Park, and Dog Beach
- Skateboards, bicycles, scooters, or rollerblades on sidewalks, boardwalks, seawalls or piers
- Overnight camping in any manner
- RVs, travel trailers, or campers at any time

## **General Information**

- Kayak, canoe, and boat launches are allowed
- Fishing and casting from the Pier are allowed (not from the Dog Park or boat launch pier)
- Waterside gazebos are first come, first serve only
- Large pavilion may be rented with the Parks & Recreation Department
- Grilling is ONLY allowed at the large pavilion with the provided grill
- No lifeguard on duty Swim at own risk
- Boats may not congregate or dock on or near the fishing/swimming pier
- At Dog Beach, all dogs must be accompanied by a human visitor
- Only vehicles with attached trailers may park in the Boat Ramp East Parking Zone
- Visitors to Dog Beach must park in the West Parking Zone or North Parking Zone and not in the East Ramp Parking Zone, which is reserved for handicapped spaces
- Shoreline Park South is an ADA-friendly park. Be respectful and keep dogs under direct control and away from the gazebos, shoreline, and Wetlands Trail Boardwalk

## Parking Information

- Parking availability is not guaranteed
- Shoreline Park South requires registration for an annual pass or pay-to-park hourly parking unless the vehicle is registered to a handicapped person and/or disabled veteran with identification
- For motor vehicle annual passes, hangtags must be placed on the rearview mirror facing out, or decals must be on the bottom passenger side of the front windshield
- For trailer annual passes, stickers must be placed on the passenger side of the tongue, between the winch and the front coupler
- All non-city residents and hourly parking must be signed into the Flowbird Parking App in the appropriate zone
- Parking rates expire at 24 hours and must be re-registered
- No decoupled trailers
- · Parking is only permitted in designated zones
- Vehicle with Trailer Parking Zone 1
- Vehicle-only parking Zones 2 & 5 (Shoreline gazebos and in front of the Wetland Trails Visitor Area and Bark Park)
- Vehicles and/or trailers first-come-first-serve Zones 3 & 4

Violation of any of these rules may result in citations or impoundment.
